PARENT RESPONSIBILITIES

Each family will be responsible for fundraising, attending **two mandatory parent meetings** and contributing to operational support during the year.

To help keep tuition cost down and maintain our high quality program, FJDS has an annual fundraising obligation of **\$200** per year, per family, regardless of your child's start date. FJDS plans and organizes two major fundraisers during the year. Each family **MUST** participate, or pay an opt-out fee designated by the FJDS Board of Directors. The opt-out fee only relieves families of working and attending the fundraiser – it does not replace the fundraising obligation.

INSPECTION AUTHORITY

Inspection Authority per section #101219 (A) Admission Agreement which references section #101195 (B) & (C) below. FJDS State Facility License # 100407341

- A. The Department of Social Services, Child Care Licensing Agency shall have the authority to interview children or staff, and to inspect and audit child and facility records without prior consent.
- B. The Licensee shall make provision for private interviews with any child, or staff member, and shall have the right to examine all records relating to the operation of the facility.
- C. The Department of Social Services shall have the authority to observe the physical condition of children, including conditions which could include abuse, neglect, or inappropriate placement, and to have a licensed medical professional examine the child.

All families are issued a Parent Handbook at the beginning of the school year, explaining the Fresno Jewish Day School's standing rules, policies, and guidelines. In addition, a signed financial contract will be required prior to admission.
